BACKGROUND

Grandfamilies – families in which grandparents or other adult family members are raising children – are a growing population of families needing unique support to help children thrive. 2.5 million children were raised by Grandfamilies in 2022 across the U.S.^{1,2}

HOUSING CONSIDERATIONS & SOLUTIONS

In their 2019 report "A Place to Call Home: Building Affordable Housing for Grandfamilies," Generations United outlined a variety of ways to support grandfamily housing needs.³

Ways to Support Grandfamilies without Specially Designed Housing

1.

"Section 8" Housing Voucher Program Subsidized Rental Housing

- The Fair Housing Act makes clear that grandparents and other relatives cannot be required to have legal custody of children in their care to qualify for assisted housing.
- Explicitly clarify in federal, state and local policies that the Family Unification Program (FUP) Vouchers program should allow relatives raising children to use these vouchers

Accessory Dwelling Units (ADUs) for Grandfamilies

- Grandparents raising grandchildren in their own home may need more space. ADUs can help address this need

"Handyman" Programs

- Handyman programs provide free or discounted services such as child-proofing to older adults or people with disabilities.
- Funding streams may include HUD Community Development Block Grant, Older Americans Act, or other city or private funds

Kinship Navigator Programs

- Kinship navigators can provide information and referral for grandfamilies and also educate front line housing staff on grandfamilies' strengths and needs
- Westchester kinship navigator: Family Service Society of Yonkers

Considerations for Creating Grandfamily Housing

Grandfamily housing takes many forms, but all have the goal of providing affordable, convenient housing for multigenerational families. This involves features for all generations (e.g., child locks for children; support bars for grandparents) and can be standalone housing or integrated with other populations of families involved in the child welfare system.



COUNTY SPOTLIGHT: LARIMER COUNTY, CO

Starting in 2006, a grandparent peer support group, along with a range of county supports, launched the Larimer County Grandparents Raising Grandchildren Support Group. Evaluations in 2008 showed a slew of benefits for grandparents, grandfamilies, and the community.⁴

GRANDFAMILIES IN NEW YORK STATE

In their 2018 study of grandparent caregivers, Polvere and colleagues⁵ conducted focus groups with 46 grandparents and 34 youth from Harlem, Middletown, Plattsburgh, Rochester, and Yonkers, New York to hear their perspectives on housing needs of grandfamilies. Grandparents and youth described housing challenges that stemmed from four problem domains:

- 1. Challenges related to poverty
- 2. Age-related physical challenges
- 3. Changes in family composition
- 4. Obstacles to obtaining benefits

"I rent. The problem is we're grandparents and we have grandchildren. That's the problem getting any apartments, senior housing, they don't want you to come in with your children. They're making all this housing and everything for seniors...so this is our problem that we have. Since we took on the responsibility of having our grandchildren, we have problems getting housing." – Grandparent, Yonkers

The authors' recommendations for better supporting grandfamilies included:

- o Protect and expand affordable housing for grandfamilies
- o Extend the same benefits to grandparents that non-kinship foster parents receive
- Advocate for grandparents raising grandchildren, particularly regarding their housing rights and custody arrangements
